The bank advice and the application shall be presented for issue of the Bidding Document, to the address below at 8(a).

All bids must be accompanied by a Bid security of **UGX20,000,000** (Shillings Twenty Million Only) in form of a bank guarantee. The Bid Security must be valid until 30^{th} July 2025. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 1115hrs on 21^{st} October 2024
